Includes horse feed, daily stall care, labor to feed, water, pasture, daily turn in/turn out, stall bedding, winter blanketing and summer fly mask on/off. Rate includes one (1) riding lesson per week no additional cost.

Definition of Feed: Up to 6 pounds of 12% protein horse pellets fed daily at night. (Currently using Purina Brand Performance Pellets. Alfalfa pellets and oats. Pasture grass - unlimited during spring, summer and fall. Hay as available from supplier fed daily - up to 4 flakes per day. Definition of Bedding: Up to 14 cubic feet of shavings per week.

Special conditions as defined by owner and Sunburst Farm, LLC: Horse Training rate is \$XXX.00 (XXX dollars) per horse/ per month. Evaluation of progress will be made and given on a monthly interval.
